- Candidates who are appearing for final examination of DM/M.Ch may also apply against the advertised posts of Assistant Professor in respective department, provided they produce the pass certificate at the time of interview

- Educational Qualification and Experience:** A medical qualification included in the first or second schedule or part II of the third schedule of the Indian Medical Council Act, 1956. Persons possessing

qualifications included in part II of the third schedule of the said act shall also fulfill the conditions specified in sub-section (3) of the section 13 of the said act. In addition, a postgraduate/Post Doctoral qualification recognized by the Medical Council of India (MCI)/NBE, or equivalent thereto for each post, is required. Candidate should have completed total 14, 6 and 3 years of teaching and/or research experience at a recognized institution, after obtaining the post graduate qualifying degree for the posts of Professor, Associate Professor and Assistant Professor, respectively as on last date of submission of application **OR** 12, 4 years and 1 year of teaching and/or research experience, respectively, after obtaining the degree of DM/MCh (2-year duration) in the concerned specialty **OR** 11, 3, 0 years of teaching and/or research experience after obtaining the degree of DM/MCh (3 years duration) in the respective specialty as on last date of submission of application.

Pediatric Specialities where MCI/NBE norms does not exist. Selection committee may consider or recommend suitable and reasonably qualified person to the post of Chief Consultant, Senior Consultant or Consultant, as per By-Laws of Institute para 28(2)

In addition, applicable non-practicing allowance (to medical candidates) and other allowances as per the Institute rules will be paid. New pension scheme of the government will be applicable.

7. **Upper age limit:** 50 years as on the last date of submission of the application. The age limit may be relaxable, for government servants, and candidates belonging to scheduled castes / scheduled tribes / other backward class as per rules.

- Retired Professors/ faculty from Govt. Institutions/Army personals may also apply for the post of Professors to be considered by the Selection Committee if the suitable candidates are not available, vide G.O. 119/2018/2842/71-2-2018-33/2018 dated 20-09-2018, and G.O. 32/2020/1418/71-4-2020 dated 01-10-2020 on contract basis, upto the age of 70 yrs on a fixed salary of Rs 2,20,000/-PM

8. The reservation norms shall be determined as per U.P Govt. rules. Such applicants must have the reservation certificate from the authorities of U.P only and not other states. If belonging to Scheduled caste/ other backward caste/ ex- servicemen category/ Physically Handicap etc. a certificate from competent authority in support of the claim, issued not earlier than 6 months before the last date of receipt of application.

9. Copy of all academic records, Experiences etc., including official certification of each degree earned from each institution of higher learning attended and official transcripts of each examination passed (if the record are not in English/ Hindi, a certified English/ Hindi translation must be provided)

10. A declaration that the entries made by you in the application are correct to the best of your knowledge and that nothing has been left out by you in intentionally must be agreed while filling the online applications. In case of false declaration form will be rejected.
