- **3.** Number of the posts may be decreased or increased at the time of the interview with or without prior information.

- **5. Educational Qualification:** As per prevalent MCI/NMC/DCI norms.
- 6. Experience: Candidate should have completed total 14, 6 and 3 years of teaching and/or research experience at a recognized institution, after obtaining the post graduate qualifying degree for the posts of Professor, Associate Professor and Assistant Professor, respectively as on last date of submission of application OR 12, 4 years and 1 year of teaching and/or research experience, respectively, after obtaining the degree of DM/M.ch. (2-year duration) in the concerned specialty OR 11, 3, 0 years of teaching and/or research experience after obtaining the degree of DM/M.ch. (3 years duration) in the respective specialty as on last date of submission of application. Please note that for minimum Teaching experience, the candidate has to fulfil experience as per NMC/DCI norms.
- 7. **Pay scales**: As per 7th CPC recommendation
 - i. **Professor :** Level 14A (as per 7th CPC)
 - **ii.** Associate Professor : Level 13A1 (as per 7th CPC)
 - iii. Assistant Professor : Level 12 (as per 7th CPC)

In addition, applicable non-practicing allowance (to medical candidates) and other allowances as per the Institute rules will be paid. New pension scheme of the government will be applicable.

8. Maximum Age-Limit and Age Relaxation:

- i. Upper age limit shall be 50 years as on last date of online application.
- ii. No age relaxation would be available to SC/ST/OBC candidates applying for unreserved vacancies.
- iii. Age relaxation permissible to various categories is as under:

- iv. Age relaxation permissible to other categories would be as per U.P. Govt. rules
- **9.** The reservation norms are as per U.P Govt. rules. Such applicants must have the reservation certificate from the authorities of U.P only and not other states, issued not earlier than 6 months before the last date of receipt of application.

- **10.** All candidates are permitted to apply against posts earmarked for EWS subject to the following conditions:
 - i. That their candidature will be considered only if EWS applications are not available.
 - **ii.** That their candidature will be as UR candidates only, which means, there shall be no relaxations which are otherwise permitted under their specific categories.
 - iii. Under no circumstances, the fee will be reimbursed.
- **11.** Copy of all academic records, Experiences etc., including official certification of each degree earned from each institution of higher learning attended and official transcripts of each examination passed (if the records are not in English/ Hindi, a certified English/ Hindi translation must be provided).
- 12. An Affidavit (Rs. 20/-)declaring that the entries made by you in the application are correct, to the best of your knowledge and that nothing has been left out by you intentionally, must be submitted while filling the applications. In case of false declaration, form will be rejected.
- 13. Processing fee (non-refundable) of Rs. 5000/- for UR and 3500/- for SC/ST/OBC/EWS should be deposited by Demand Draft in favour of "PGICH-ACADEMIC ACCOUNT" Payable at Noida at the time of submission of application form.
- **14.** Persons working in Govt. jobs should apply, through proper channel and MUST produce the "No-Objection Certificate" issued by their present employer at the time of application/interview.
- **15.** The Candidates may be short listed for the interview by the Institute subject to the number of application against the advertised posts whenever required.
